ToF Hub is envisaged as a facilitation center that will provide relevant information and extension support to farmers/stakeholders in ToF Domains like Prevailing and Possible Agroforestry Models, Facilitating QPM sourcing for farmers, and technical guidance/awareness for Agroforestry operations, etc.

The position is responsible for supporting the State team in the implementation of the Trees Outside Forest in India (TOFI) work plan in the given area /state.

Number of Positions: 28 (4 per state; Andhra Pradesh, Assam, Bhubaneswar, Haryana, Rajasthan, Tamil Nadu, and Uttar Pradesh (Purely on a Job contract basis).
